We have only a few people that have not paid their 2020 dues. Working with our Comptroller, Greg Rapelje, and our Admiral, Chris Scanlan, we have decided to not take any action on suspension until after the COVID-19 emergency is over. The District Biennial meeting was held online on April 4, 2020. The quick summary is that all of the resolutions regarding the uniform passed, all of the resolutions regarding updates to the Form 4 passed, and the resolution for better feedback from Supreme was withdrawn by the two assemblies that submitted it. (There was some feeling that as worded, it would have been out of order, so we will need to reconsider it.) Jim has been doing preliminary work on it for about 18 months, and we are only about six months away from the event. We know we will be at St. John Neumann, 44800 Warren Ave, Canton, MI, and we will start with 4:30pm Mass. We expect to have dinner, some speeches (can't avoid it) and some music and dancing. Regarding the prayer list, we currently have over 150 intentions, which is a lot. Some are 2½ years old.
